Ron Ruston – Plexus Law

Ron has dealt with local authority claims for the last 12 years dealing with Employers', malicious prosecution & misfeasance in public office and Public liability claims including highways, false imprisonment, mental health, property and subsidence & coverage. He represents insurers and self-insureds on liability and coverage issues for EL, PL and motor.

Ron, as a former criminal duty solicitor, undertakes regulatory work including motor on behalf of insureds drivers, Environmental Agency and Health & Safety prosecutions. This covers such areas as death and serious injury by dangerous driving with representation in interviews under caution, coroners, magistrates and crown courts.

In addition, he regularly advises and represents public authorities and insurers on issues of data protection and discrimination including disability, race and sex together with a number of fraudulent claims nominated by insurers on all issues of public and employers' liability.
